## Do I need a Commercial Feed License?

| Ingredients  | I distribute single ingredient commodities such as almond hulls, canola meal, and soybean meal.  | <b>✓</b>             |

| Species   | I (distribute/manufacture/sell/store) feed for animal species utilized for human consumption or economic gain, including but not limited to: beef, swine, dairy, sheep, goats, poultry, laying hens, gamebirds, rabbits, honeybees and horses, and am not otherwise eligible for exemptions. | <b>✓</b>             |
|   | I only (distribute/manufacture/sell/store) feed for domestic pet species such as dogs, cats, exotic birds, and rodents which is solely intended for and specifically labeled as "pet food".  | ×                    |
| Toll<br>Manufacturing,<br>Selling Under<br>Label Name | I contract a feed mill to manufacture and distribute feed for my company with my name on the label. (I need to obtain a license at both my headquarters address and the address of the feed mill manufacturing the feed).  | <b>✓</b>             |
|   | I contract a feed mill to manufacture feed for my company and then I physically receive all of the product prior to distribution to the customer. (I need a license for my location(s), but not at the contracted feed mill.)  | <b>✓</b>             |
|   | I open sacks of feed at my facility/store to allow for "by-the-pound" sales and/or I re-package commercial feed from another manufacturer, requiring my name to be on the label.   | <b>✓</b>             |

## License Required?

Human Food Processing/ Manufacturing Facilities I am a human food facility producing a by-product which is diverted to commercial feed.

All of the by-products I produce are distributed by a licensed broker. (I still need a license because I am the manufacturer of a product intended for commercial feed. The broker ALSO needs a license.)



Human Food Retail, Restaurants I am a retail store or restaurant selling food originally intended for human consumption ONLY. Any and all recovered food (past sell-by date, off spec, etc.) that may be diverted to animal feed is collected by a commercial feed licensee.



I am a retail store or restaurant and I sell and/or donate excess/expired/off-spec human food directly to livestock producers/customers.
